- 3. Your personal data is processed only for the purpose of:
 - a. the provision of health services in connection with performing medical activity in accordance with the Act on Medical Activity taking into account the provisions of Patient Rights and Patients Ombudsman Act, your personal data is processed under Article 6 of Act 1 point c) and Article 9 of Act 2 point h) RODO;
 - b. preventive care and personal data is carried out on the basis of Article 6 of Act 1 point c) and Article 9 of Act 2 point h) RODO in relation to Article 3 of Act 2 on medical activity and Article 24 of Patient Rights and Patients Ombudsman Act;
 - c. medical diagnostics and treatment on the basis of Article 6 of Act 1 point c) and Article 9 of Act 2 point h) RODO in relation to Article 3 of Act 2 on medical activity and Article 24 of Patient Rights and Patients Ombudsman Act;
 - d. provision of health care, and management of health care systems and services on the basis of Article 6 of Act 1 point c) and Article 9 of Act 2 point h) RODO in relation to Article 3 of Act 2 on medical activity and Article 24 of Patient Rights and Patients Ombudsman Act;
 - e. social security provisions management of social security systems and services on the basis of Article 6 of Act 1 point c) and Article 9 of Act 2 point h) RODO in relation to Article 54 of Act on social insurance cash benefits in respect of sickness and maternity or other relevant provisions of social security legislation;
 - f. marketing, in relation to carrying out clinical trials or scientific research based on your voluntary consent;

- 5. Your personal data may be shared with:

 - b. Other healthcare providers collaborating with the data controller in order to assure continuity of treatment and availability of health services
 - c. Social Insurance Institutions in cases prescribed by law,
 - d. Public and local authorities, judicial authorities or other entities in accordance with applicable law,
 - e. Person/s authorized by you or statutory representatives,

- f. Entities providing the data controller with legal support and accounting or IT services
- g. Operators offering postal services or courier companies.
- 6. Your personal data may be transferred to your country of origin including third countries, if this is follows from your chosen form of settlement of costs for health services.
- 7. Your personal data collected for the purpose of provision of health services as well as your medical records are to be stored by the Data Controller for, as a rule, 20 years from the date of its last entry, unless other periods are provided for by law. The data controller has a right to process personal data for the purpose of pursuing claims in periods specified by the Civil Code. All data processed for the accounting purposes and tax reasons are processed in 5 years starting from the end of calendar year in which the fiscal obligation was imposed.
- 8. You have a right to access your personal data, rectify or erase them, as well as restrict their processing or object to their processing.
- 9. You have a right to file a complaint to the supervisory authority President of the Personal Data Protection Office, located at Stawki Street 2, 00-193 Warsaw.
